Superintendent's Report

Superintendent Read shared a district enrollment of 211.92 FTE and current COVID counts as 7 students. Mr. Read continued by sharing information on the short legislative sessions which will end in March. The primary responsibility of this session will be updating the state's two-year budget and address any unfinished business from last year's session. Several bills have been presented including potential fixes to the prototypical funding model and possible enhancements for funding for nursing, counseling, and social-emotional learning.

Principal's Report

Principal Nelson reported we continue to communicate with Lincoln County Health Department about correctly following Covid guidelines and protocols with students and athletes.

Nelson welcomed Mark Sebesta to our custodial team.

Nelson also reported Kimberly Ryan and the elementary teachers hosted a family night on January 13th with learning games, hot chocolate and popcorn. Approximately 150

students, family members and staff were in attendance. Cheerleaders also volunteered their time to help out during the evening.

Knowledge Bowl has been doing well with in person competitions this year. An all school academic assembly is scheduled for February 11th and Kindness Week with be February 14-18th for the elementary. Honor Band students will perform on March 28th at the Fox Theatre in Spokane.
