Superintendent's Report

Superintendent Read shared the most recent student count of 213.6 FTE. He continued by informing the school board that the free meals for all students will conclude at the end of the school year. Students who are eligible for free or reduced meals will still be able to participate in those programs during the 2022-2023 school year and beyond.

Read continued by providing information on the potential heating system upgrades which will hopefully be funded through the ESSER III funds. Quotes and or bids will be reviewed at the May board meeting as well as timelines for the project.

Principal's Report

Principal Nelson reported a PreK-12 enrollment headcount of 240 students. The Smarter Balanced State Assessments are underway and Nelson thanked Mrs. Ryan for all her hard work creating a testing schedule.

Nelson reported the 5th-12th grade students performed their spring concert on April 18th and the elementary will have their music concert Friday April 29th. The junior high and high school band will be marching in the Lilac parade on May 21st and will also perform at Silverwood on June 6th.

FBLA State competitions were held last week in Spokane with ten teams moving on to nationals in Chicago this summer. Odessa received the Outstanding Chapter of the Year award and Jamie Nelson received the FBLA Administrator of the Year award. FFA will be

attending state convention on May 11-14 in the Tri-Citles and May 30th-June $1^{\rm st}$ in Pullman. The annual plant sale will be this Saturday at the Ag Shop Greenhouse. The senior trip to Triple Play is scheduled for May $5^{\rm th}$. The senior recognition assembly and walk will be June $1^{\rm st}$. Graduation is scheduled for June $4^{\rm th}$ in the gymnasium.

Principal Nelson shared that kindergarten teacher interviews were held and Sidney Sheer has been selected pending board approval.
