REPORTS	<p>Superintendent's Report</p> <p>Superintendent Read shared the average student count for the school year as 213.95 FTE compared to the amount budgeted last summer of 209. Mr. Read continued by discussing with the school board the transition plans with the incoming superintendent John Bruce which includes end of year reporting, grant applications, and general duties and responsibilities attached to the superintendent position.</p> <p>Principal's Report</p> <p>Principal Nelson reported a successful graduation week. Activities included the senior walk and recognition assembly, a BBQ lunch hosted by Mr. Read, and graduation on Saturday.</p>

Nelson also reported Mr. Harder took the band to Silverwood, Mrs. Walter and the seventh-grade class held a K-5 field day, Mrs. Wehr and the eighth-grade class held a science fair for the elementary students, and Mrs. Ryan and the elementary teachers hosted a move up day for the elementary students.

FFA members attended their state conference and officers were elected at the annual banquet at the golf course. FBLA elected officers and are preparing for their trip to Nationals in Chicago. 
