Superintendent's Report

Superintendent Bruce reported 13 students will undergo highly capable testing in February. Bruce shared he has received inquiries for both music and special education open teaching positions, and discussed possible grants the district could consider for the school nutrition program.

Principal's Report

Principal Nelson reported January has been a highly educational time. The online credit recovery program will begin second semester and highly capable testing has been postponed until February. Math teachers began working with the ESD to improve math scores.

Nelson reported FBLA will attend their winter conference on January 30th and FFA will attend the Ag Show on February 9th.

Board Report

The board thanked John Bruce for coming down to the lower 48 and being the district's Superintendent for the last several months. The board also thanked Ellen Holman, Hollie Eden, Jeff Nelson, Matt Gorman, and Cade Weber for their service to the district.

AD Report

Athletic Director Larry Weber reported the high school basketball teams will be seeded for districts after Saturday's game. Weber shared additional junior varsity games are scheduled against Warden on the 26th. A fundraiser for a student with cancer will be held during the game against Wilbur/Creston/Keller on Saturday. Weber reported schedules for high school volleyball and football are complete for Fall 2023.

The junior high boys basketball team has 13 participants and the junior high baseball season has been canceled due to lack of players.

Weber shared the following open coaching positions: JH Head Track Coach, HS Head Baseball Coach, HS Assistant Baseball Coach, HS Head Football Coach, 2 Assistant Football Coaches.

Legislative Report

Superintendent Bruce shared current legislative discussions about fully funding special education and student transportation.

Facilities Report

Justin Parr shared about two legislative house bills currently on the table concerning fully funding transportation and requiring outside cameras on school buses that would issue automatic tickets for stop paddle traffic violations. Parr also shared he is working through details with the HVAC

project, the new bus has arrived and the facilities committee will meet next month.

Financial Report

Superintendent Bruce presented the ASB balance sheet for December. He further presented the Financial Activity reports for General Fund for December showing an unassigned fund balance of \$807,532.25. He presented computer printouts for all funds.
